5. Transmissions are guaranteed to work properly at the time of purchase. Gears are guaranteed to be in good condition at time of purchase. Flush and inspect transmission cooling lines and add fluid levels to manufactures suggested levels. There is no responsibility for improper installation by customers.
6. Rear ends are guaranteed to work properly at time of purchase, gears are guaranteed to be in good condition at time of purchase, bearings are guaranteed to be without material noise at time of purchase. There is no responsibility for improper installation by customers.
7. Radiators and heaters are guaranteed not to leak at time of purchase. Batteries are guaranteed to hold charge.
